

The Details/ data required to be submitted by the Private Company

- Company Profile.
- Income Tax Return for last 3 years.
- Audited balance sheet/P&L Statement for last 3 years.
- PAN.
- GSTN NO
- UAM / SME registration No (if available)
- Start-up registration no (if available)

The work flow/ flow chart of the complete process.

- Test facility request.
- Registered private vendor shall submit the end use certificate, Non disclosure declaration
- The Nodal agency in respective BDL unit will study the technical specs of the test to be carried out.
- Slot availability along with quote will be communicated to the vendors in case the available test facilities are capable of meeting the technical requirements.
- Private party shall place Service Order including acceptance of payment terms as per the quote.
- On acceptance of service order by BDL, the party will hand over the item to be tested at respective unit.
- The test(s) will be carried out as per standard procedures by BDL personnel only.
- The item will be returned back to party duly stamped by the BDL security .
- The test reports will be handed over to the private entity after receipt of payment.

Important terms and conditions to be complied by private company requesting for test facility

- The test services to private parties will be made available, only in case of spare capacity, over and above meeting the internal needs.

- All transportation of job/item (including loading/unloading) from/to BDL Unit, testing premises is the responsibility of the private party only.
- Personnel from party are to produce proof of Identity/authorization letter.
- BDL security will check the DC and items and allow the job/item before permitting in /out of its premises.
- The testing charges are fixed at nominal rates taking into account all direct & setup costs (generally on hourly basis).
- The Hourly Rate indicated in the list, are for budgetary purpose only. The rates may vary and the actual rates will be indicated in the quote.
- The test charges are applicable for standard test procedures. In case of any additional tests, charges will be suitably modified depending on the job specifications.
- Applicable charges exclusive of GST.
- The party has to take back the job/item after the completion of test within 30 days beyond which BDL shall not be responsible for returning back the item to party.
- BDL will not be responsible for loss/damage to the job/item while carrying out the test(s).
- All necessary insurance coverage for the job shall be the responsibility of the private party.
- If any damage occurs to equipment/property/personnel resulting from the testing of the job of private party, the private party should bear the expenses.
