7. <u>Mode of Selection</u>: Selection of eligible candidates for imparting training under the Apprentice Act 1961 will be based on Merit as detailed below:

- List of candidates applied for various trades will be drawn separately.
- A common Merit list will be prepared based on the marks scored by the eligible candidates as per the essential qualification. Equal weightage will be given for marks obtained in 10th/SSC and ITI pass.
- The Candidates at 1:3 ratio will be called for **counselling**. Based on verification of original documents, the offer shall be issued as per the merit.
- In case of **absent of the shortlisted candidate(s)** for counselling, the offer shall be issued to the next attended candidate(s) as per merit list.
