"INDEPENDENT INDIA @75: SELF RELIANCE WITH INTEGRITY"

MESSAGE FROM CMD

I am very pleased to learn that Vigilance Department of Bharat Dynamics Limited is organizing "Vigilance Awareness Week-2021" from 26th Oct,2021 to 01st Nov, 2021. The theme chosen by the Central Vigilance Commission (CVC) for this year is "Independent India @75: Self Reliance with Integrity". The chosen theme is very apt as our Country is celebrating 75 years of its independence. The Government of India has given a clarion call for expanding manufacturing base including Defence Manufacturing with the motto of 'Make-in-India' and 'Atma Nirbhar Bharat'.

2. In this connection, as the theme is broadly based on Independent India's journey of 75 years in the direction of Self-Reliance, I would like to present the journey of BDL here. BDL has been focusing on indigenising technology for self-reliance from the day, contract is signed. In the case of Konkurs-M and Invar missiles, even though technology transfer was limited, BDL took the initiative and achieved an indigenous content of 80 to 95%. However, BDL's most of the products on an average are indigenised by more than 90%. The left over percentage is because of economic non-viability to develop and lack of sufficient quantity of orders. However, BDL is putting all out efforts for further indigenisation of left over percentage in a phased manner.

3. Steps taken by BDL to achieve self-reliance in defence equipment productions:

- a) Implementation of Make-II procedure at BDL: A frame-work for implementation of Make-II procedure at OFB and DPSUs was issued by MoD on 11th Feb 2019. The objective of the framework is to inter alia, incorporate features on Make-II in the procurement manuals of OFB and DPSUs so as to empower them to take up project for indigenization of items, particularly the ones being imported regularly. Accordingly, BDL has amended the IMM manual incorporating the Indigenization of components and spares of BDL products and procedure (Amendment nos. 15 and 16 dated 20-05-2019).
- b) Srijan Portal: MoD's indigenization portal SRIJAN which is a 'one-stop shop online portal' that provides access to the vendors to take up items that can be taken up for indigenization. In this portal, as on date, BDL has uploaded 427 items. These 427 items include all the items imported by BDL.
- c) AtmaNirbhar Bharat (Indigenization Plan): BDL has made an Indigenization Plan for Five Years (2020-21 to 2024-25) and set a target of indigenization of 166 items. Against the target of 72 items to be indigenized during the year 2020-21, 79 items indigenization is completed.
- d) Products developed under Make-II: BDL is designing and developing indigenous 3rd generation ATGM named as Amogha III. At present, 3rd generation ATGMs are not manufactured in India and are being imported. The product is being developed as a Make-II project under Indian Indigenously Designed Developed and Manufactured (Indian IDDM) category of Defence Procurement Procedure.

4. Bharat Dynamics Limited (BDL), a Government of India Enterprise under the Ministry of Defence observed 'Atmanirbhar Bharat' Week from 7 Aug to 14 Aug 2020. As a part of this, several events have been organized by BDL during the week to take forward the 'Atmanibhar Bharat Abhiyan' initiated by the Government of India.

5. Keeping pace with the latest technology and the requirement of high quality and reliability in the manufacture of Defence equipment, BDL has set-up /setting-up the following facilities:

- a) Surface-Mount Technology (SMT) facility for producing electronic circuits in which the components are populated directly onto the surface of printed circuit boards (PCBs).
- b) BDL has also established 'High Performance Computing facility' which will facilitate in conducting the Aerodynamic and Structural analysis at a faster rate.
- c) BDL is establishing a Seeker Facility Centre (SFC) for manufacturing and testing of indigenously developed Seekers for missiles. SFC has been designed to be Modular so as to suit other Seekers with an incremental change / addition.
- d) BDL is also establishing a Warhead Production Facility for manufacturing and testing of indigenously developed warheads. This facility has been planned to initially cater for Anti-Tank Guided Missiles and Air- to-Air Missiles. This facility is designed to adapt to all future developments in warhead technology and Missiles.

The above facilities will help India to be more self-reliant in the design and manufacturing of Missiles.

6. I am pleased to note that Vigilance Department of BDL is bringing out the 2nd edition of the Vigilance Newsletter 'CHETANA' during the Vigilance Awareness Week-2021.

7. I wish to place on record my appreciation for Dr. Upender Vennam, IPos, Chief Vigilance Officer who has issued 12 systemic improvements as on 12.10.2021 after VAW-2020 intended to streamline the procedures for betterment of the Organization. A total of 43 systemic improvements were issued since his joining. All these systemic improvements are intended for enhancing the transparency, efficacy in functioning keeping in view the overall growth of the organization.

8. I Congratulate Chief Vigilance Officer and his entire team for putting in their best efforts in bringing out 'CHETANA' successively for second year.

MESSAGE FROM DIRECTOR (TECHNICAL)



BDL'S TECHNOLOGICAL JOURNEY TOWARDS SELF - RELIANCE

I am happy to note that "Vigilance Awareness Week-2021" with the CVC theme 'Independent India@75 : Self Reliance with Integrity@75' is being observed from 26th Oct, 2021 to 01st Nov, 2021 across units of our Company.

In this connection, I would like to mention that Bharat Dynamics Limited (BDL) was incorporated on 16 July, 1970 as a PSU under Ministry of Defence, Government of India to be the manufacturing base for guided missile systems and allied equipment for Indian Armed Forces.

While fulfilling its basic role as a weapon system manufacturer, BDL has built-up its in-house R & D capabilities primarily focussing on Design & Engineering activities and reduce dependency on foreign OEMs. These efforts have resulted into several value added products like FLAME and in-house developed products like CMDS, Amogha, KLTE, KMTE etc.

BDL has also been focusing on indeginization of technology for achieving self-reliance. In the case of ATGMs being manufactured under ToT with foreign OEMs, BDL has achieved indigenization between 80-95%.

To give an impetus for the realization of Atmanirbhar Bharat, BDL has taken up several initiatives to modernize its production facilities. These include setting up of facilities such as Seeker Facility Centre, Warhead Production facility and High Temperature Carbon Composite Manufacturing Facility. In addition to these, the Surface-Mount Technology centre and High Performance Computing Facility have been set up at BDL.

BDL is also employing emerging technologies like AI, industry 4.0 to offer indigenous advanced systems to the Armed Forces.

BDL is focusing on several sub-surface projects to enhance Self-reliance with respect to Indian Navy. Few of these in pipeline are Generic Combat Management Simulator for the Submarines and Surface Ships of the Indian Navy where BDL has been identified as an Indian Partner, Electrical Heavy Weight Torpedo under design and development with NSTL, Most Advanced extended range light weight Torpedo (Garudastra), Anti Torpedo Decoy System with Rafael (The Shade System) and as an Offset Partner for manufacture of HWT by Naval Group France under Project.

The Company is encouraging 'start ups' for their participation in developing new technologies. The procedures have been simplified to encourage their participation. BDL is also ready to share its spareable test facilities with 'start-ups' for testing of materials / sub-systems / equipment.

The pursuit of technological excellence has always been the guiding force of the Company and BDL continues to remain committed to contribute towards achieving self-reliance in defence and realization of "Atmanirbhar Bharat."

It is encouraging to know that Vigilance Team at BDL is bringing out 2nd edition of annual newsletter 'CHETANA' during the Vigilance Awareness Week 2021 which would help to spread awareness on anti-corruption.

I would like to convey my best wishes to Dr. Upender Vennam, IPoS, CVO and Team of Vigilance department for their efforts towards organizing various activities during the course of Vigilance Awareness Week-2021.

MESSAGE FROM DIRECTOR (PRODUCTION)



BDL's PRODUCTION JOURNEY TOWARDS SELF- RELIANCE

I am pleased to note that Vigilance Awareness Week 2021 is being observed in Bharat Dynamics Limited during 26.10.2021 to 01.11.2021 with the theme 'Independent India@75 : Self Reliance with Integrity@75' as decided by the Central Vigilance Commission (CVC).

On this occasion of observance of Vigilance Awarness Week 2021, I would like to mention that Bharat Dynamics Limited (BDL), was incorporated on 16 July, 1970 as a Public Sector Undertaking under MoD, GoI to be a manufacturing base for Weapon systems and allied equipment for the Indian Armed(IA) Forces.

Since its inception, BDL has been working in collaboration with DRDO & foreign Original Equipment Manufacturers (OEMs) for manufacture and supply of various missiles and allied equipment to Indian Armed Forces. These weapon systems to meet the requirement of Armed forces and the Export Market.

BDL's Procurement and Production Policy is aligned to GoI's Master Indigenisation Plan. Progressively over the years, BDL has ensured reduction in import content of its weapon systems. It was a challenge to take forward an indigenization programme.

BDL has been focusing on indigenizing technology for self-reliance for both ToT items as well as DRDO designed products. In the case of Konkurs-M and Invar missiles, even though technology transfer was limited, BDL took the initiative and achieved an indigenous content of 95% and 87% respectively. Efforts are being taken to further increase the indigenisation percentage of above products. BDL has made an Indigenization Plan for Five Years (2020-21 to 2024-25). Against the set target of indigenization of 166 items, BDL has exceeded the set target under "Atma Nirbhar Bharat" during the year 2020-21.

MoD's Indigenization portal, SRIJAN, BDL has uploaded 427 items. These 427 items include all the items imported by BDL with value of imports.

To reduce the import dependency and cost effectiveness, BDL has successfully indigenized the INVAR Warhead. Established in-house, 50 Tonne Rocket motor static test facility for SAMs. It is one of the most sophisticated state-of-theart test facility. In all the missiles, rocket motor is an essential and critical sub system.

BDL has been constantly upgrading its manufacturing technologies and processes to state-of-the-art including Industry4.0, Robotics operated workshops and modernization of management system and less dependency on import technology. BDL is implementing Industry 4.0 for Konkurs-M launcher.

BDL is setting up new manufacturing facilities for seeker production activities, warhead production and HTCC manufacturing facility. BDL is working on to establish propellant manufacturing plant at UP Defence corridor very soon.

BDL is also offering various items for indigenization to the industry including MSMEs and start-ups. The Company is also extending its technical support to its vendors including providing test facilities available with BDL.

It also gives me immense pleasure to note that the Vigilance Department of Bharat Dynamics Limited is bringing out the second edition of annual newsletter 'CHETANA' during the Vigilance Awareness Week. I hope that the contents of 'CHETANA' will help spreading awareness amongst its readers on vigilance, anti-corruption and integrity etc.

I congratulate the Chief Vigilance Officer and his team of Vigilance Department.

MESSAGE FROM DIRECTOR (FINANCE)



BDL's FINANCIAL AND HUMAN RESOURCES JOURNEY TOWARDS SELF RELIANCE

I am glad to note that the Bharat Dynamics Limited is organizing "Vigilance Awareness Week-2021" from 26th Oct, 2021 to 01st Nov, 2021 with the theme "Independent India @75: Self-Reliance with Integrity". The main objective of observance of Vigilance Awareness Week is to create awareness amongst all stakeholders towards the policy of achieving prosperity through transparency and accountability.

As we are celebrating 75 years of independence of our great nation and a vision of becoming Self-Reliance has been placed, I would like to focus on the BDL's financial and human resources journey towards self-reliance. BDL was incorporated on 16 July 1970 as a PSU under Ministry of Defence with a Paid-up Capital of Rs.10,000/- (Rupees Ten Thousand Only) with Authorised Capital of Rs.5.00Crore and commenced business with a skeletal manpower of 11 personnel. It had commenced its journey as a single product (SS11B1) company and now it is a multi-product company spanning ATGMs, SSMs, SAMs, Underwater weapons and CMDS. The company clocked profit for the 1st time during 1972-1973 amounting to Rs.0.19 Cr. Today, the reserves and Net Worth of the Company crossed Rs.2500 Crore and Rs.2685 Crore respectively. BDL achieved highest Turnover of Rs.4887 Crore during 2016-17 and PBT of Rs.847 Crore during 2015-16. The Authorized and Paid-up Capital of the company today stands at Rs.200 Crore and Rs.183.28 respectively. The Company was 100% owned by GoI till February 2018, with government offloading its stake during March 2018, it has become a listed entity. BDLs shares are listed on BSE & NSE since March 2018. Today 74.93% of Equity is held by GoI and balance by Public and institutional investors. The Company rewarded shareholders with liberal dividends and bonus shares. The Company had issued two consecutive bonus shares during 2016-17 & 2017-18 aggregating to Rs.116.08 Crores. BDL has successfully adopted International Accounting Standards (Ind AS) w.e.f 2016-17 in line with Government Directives.

Despite increase in turnover multiple times, BDL could manage with more or less same manpower of around 2800. Highest manpower 3300 was during 2012-13 and lowest being 2788 during 2008-09. Manpower as on 01 Oct. 2021 stands at 2669. During the initial days of its incorporation, the Company was headed by Chairman with day-to-day operations being overseen by Managing Director which continued till 1989-90. The positions of Chairman and Managing Director were clubbed during 1990-91 and since then, the Company is being led by Chairman and Managing Director. Coming to Finance, the function was initially headed by "Financial Controller". From 1983-84 to 1986-87, the Finance Department was headed by General Manager (Finance) and from 1987-88 onwards, it is headed by Director (Finance). The strength of Finance and HR departments as on 01 Oct. 2021 stands at '89' and '174' respectively vis-à-vis'2669' of total of manpower of the Company.

Today, with the strength of Balance Sheet, the Company is poised to take off to new horizons in the back drop of new technologies. The Company is aspiring for Joint Ventures/MoUs planned with the OEMs.

It is encouraging to note that Vigilance department is bringing out the 2nd edition of its annual newsletter 'CHETANA'. I congratulate Dr.Upender Vennam, IPoS, CVO and his entire team for this initiative.

MESSAGE FROM ED (MARKETING)



BDL's PRODUCTION & TECHNOLOGICAL JOURNEY TOWARDS SELF-RELIANCE

Bharat Dynamics Limited (BDL) was incorporated in the year 1970, as a Public Sector Undertaking under the Ministry of Defence, Government of India, to be the manufacturing base for guided missile systems and allied equipment for the Indian Armed Forces.

During its formative years, BDL worked closely in collaboration with foreign Original Equipment Manufacturers (OEMs) for manufacture and supply of various missiles. SS11B1 ATGM was the first product rolled out of the Company manufactured under French Collaboration and the first missile manufactured on Indian soil.

BDL over the years, evolved into a multi-product, multi-located enterprise manufacturing state-of-theart ATGMs such as MILAN, Konkurs and Invar for the Indian Army under licence agreement with foreign OEMs.

The lead taken by the Nation to develop indigenous, sophisticated and contemporary missiles through the ambitious Integrated Guided Missile Development Programme gave BDL an opportunity to be closely involved in the programme, wherein it was identified as the Prime Production Agency. This opened up a plethora of opportunities for the Company to assimilate advanced manufacturing and programme management technologies and skills. Thus began the technological and production journey of BDL, which paved the way towards Self-reliance.

BDL joined the elite few countries in the world capable of manufacturing SAMs by manufacturing and handing over the Akash Missile System to Indian Army in the year 2015 with 96% indigenous content involving a large number of supply chain partners which include DPSUs, MSMEs and private industry. Now, BDL is set to manufacture the Akash Prime for the armed forces.

BDL is poised to enter into new strategic weapons systems covering a wide range of weapon systems such as Air-to-Air Missiles, Air-to-Surface Missiles, Air Defence Systems, Underwater Weapons and Mines.

In order to give momentum to its efforts towards self-reliance,BDL, built up its in-house R&D capabilities primarily focusing on design & engineering activities. This approach resulted into significant achievements in the avenues of indigenization and realization of value-added products and product variants like the FLAME, CMDS, KLTE, KMTE and Amogha ATGM to name a few.

The clarion call given by our Hon'ble Prime Minister to build an 'Atmanirbhar Bharat'gave the nation the right ecosystem to move further towards self-reliance. Adapting to the new environment, BDL has taken several initiatives for realization of Atmanirbharta in Defence sector. The Company today has made a paradigm shift in its manufacturing processes by leveraging niche technologies, adopting practices like industry 4.0,operating latest Surface Mounted Devices assembly lines and developing AI based products. These have proved to be some of the enablers to contribute towards making the nation self-reliant in Defence sector.

To further take this forward, BDL has also taken up several initiatives to be a part of global supply chain by entering into MoUs/agreements with foreign OEMs. The Company is working relentlessly not only to achieve self- reliance but also to export its 'Made in India' products to friendly foreign countries and build a resurgent *Atmanirbhar Bharat*.

BDL'S PRODUCTION & TECHNOLOGICAL JOURNEY TOWARDS SELF-RELIANCE

BDL has been the singular production agency for missiles and underwater weapons and weapon systems with an astounding journey of over 51 years. BDL was set with a humble beginning of manufacture of Anti-Tank Guided Missiles (ATGMs) under licence production. Over these long years, BDL traversed the path of setting up state-of-the-art Production, Assembly and Test facilities for indigenous production of contemporary weapons and weapon systems.

Production Facilities

ATGMs, Invar, Konkurs and Milan were the credible ToT products manufactured in BDL. The complex machinery required for productionization of these missiles were set up in BDL to enable manufacture of these reliable ATGMs and supply to the Indian Army. As on date, BDL has the capacity of delivering 5000 to 8000 ATGMs per year.

BDL was chosen as Production Partner for the IGMDP programme of DRDO. Accordingly, critical and complex manufacturing facilities necessary for the same were set up in BDL. Today, BDL boasts of a modern contemporary manufacture, assembly and test facility for manufacture of ATGMs, Surface to Air Missiles (SAMs), Quick Reaction SAMs (QRSAMs), Torpedoes, Decoy systems, Sonobuoys etc. Further, there is an effort to upgrade these facilities to meet the new requirements like Air-to-Air Missiles, Anti-Radar Missiles, Smart-Anti Air Field Weapons, Strategic Bombs (Garuda & Garutma), Prithvi Deliverable Vehicle (PDV) and Advanced Air Defence (AAD) Missiles, Submarine-Launched Cruise Missile (SLCM) etc. These facilities include 5-axis CNC machines, flow-forming machines, Robotic Welding, Surface Mount Technology Lines for manufacture of various components of these weapons and weapon systems.

Technological Journey

Over the period of over 51 years of existence, BDL has been in the forefront in absorption of various technological advances. Starting from manufacture of first and second generation ATGMs to design, development and manufacture of third generation ATGMs. Similarly, from the ramjet motor command guided Akash to the Pulsed motor, seeker guided missiles like MRSAM, QRSAM. BDL has been part of a great journey of technology. The setting up of the Design & Engineering Division very early has enabled BDL in being part of this dynamic industry and is on the verge of proving its indigenously designed Man-Portable ATGM.

In addition to the above, BDL has indigenously designed and developed different types of launchers, Simulators, Test Equipment and Counter Measures Dispensing System(CMDS) to meet the requirements of Indian Armed Forces. Further, BDL is setting up facilities like RF & IIR seeker manufacturing and testing facility, Warhead and Rocket Motor filling facility etc to cater to this technological journey.

All these efforts have enabled BDLs contribution to the nation's journey towards self-reliance in an important and strategic field of weapon and weapon systems indigenous production. BDL has achieved more than 90% indigenisation of systems and sub-systems of majority of weapons and weapon systems in use by the Armed Forces of our country manufactured by BDL.

SYSTEMIC IMPROVEMENT INITIATIVES BY VIGILANCE DEPARTMENT

As a part of preventive vigilance, regular checks, surprise checks and scrutiny of procurement and civil works files were undertaken. Areas requiring systemic improvements were identified and corrective measures were suggested to the management for suitable intervention.

A total of 10 systemic improvements and good practices are suggested by the Vigilance department during this year with a total of 43 since 01.09.2019. Brief of these are furnished herewith for wider dissemination and awareness:

	Selection of vendor/supplier plays a pivotal role in checking the 'risk' of suppliers becoming the potential competitor to BDL in future. It was suggested that provisions should be made available in Manual which enable identification of the strategic or technical sensitive / confidential procurements and an SoP should be in place defining the criteria or process for strategic or technical sensitive / confidential procurements, in-line with Government guidelines. The suggestion has been accepted by the management and necessary amendments along with the SOP is yet to

	A study was undertaken by the vigilance wing on "engagement of Casuals / Contract Manpower" across units of the Company. It was observed that there is no proper mechanism to monitor the attendance of contract manpower at work place and also there is no standardized tender document. Terms and conditions in each service order are different with other. Vigilance wing suggested to implement a suitable biometric attendance system for all contract manpower. It was suggested to standardize the tender documents and route all files through CLM Cell. The suggestion is under management consideration.
3	Proper handling of disciplinary cases relating to administrative misconduct, not involving vigilance angle-
	A review was carried out on the pending disciplinary cases relating to administrative mis-conduct, not involving any vigilance angle in respect of below Board level executives. Improvements were suggested with regard to completion of departmental inquiries in a time-bound manner as per the extant instructions. Management has accepted the suggestions and actions expediting the closure of long pending disciplinary cases have been initiated.
4	Systemic Improvement on procurement of 05 types of Aluminium raw materials –
	As part of scrutiny of the procurement of high value items, certain discrepancies were noticed by Vigilance Wing in the procurement of 05 types of Aluminium raw materials. In response to BDL's enquiry, only four (4) out of nine Vendors submitted their bids / quotations. 03 bids were rejected on commercial grounds due to non- compliance of delivery schedule as per tender document. However, on the recommendations of Finance Dept., the L1 vendor of one item was asked to comply with the delivery period (03 months as per enquiry) and it complied. No efforts were made by the Division to contact the other two parties with regard to other 3 items. Had efforts been made to contact other vendors and made them comply to the delivery schedule, e-reverse auction could have been conducted. Therefore, it was suggested that indenter need to be more vigilant in such cases and to sensitize IMM and finance wing to bestow undivided attention during the whole process of procurement. This suggestion has been accepted by the Management and actions have been initiated to sensitize IMM and Finance executives regarding e-reverse auction.
5	Time-frame for Approval of DPC/Selection Committee Recommendation, furnishing of certificates by
	Committee members and related matters-
	As part of review of the systems and procedures of the Company, provisions relating to preparation of merit list (2.16) of Recruitment Rules-2012 of BDL are studied. It was observed that there is no provision in 'what time frame' the recommendations of Selection Committee/DPC are to be submitted for the approval or otherwise of the appointing authority. Also, there was no time-limit prescribed for the appointing authority to accord its approval or otherwise. Further, it was observed that as per the provision at 2.16.2 of existing Recruitment Rules, the panel is valid for 'one year' and it may be extended up to a further period of 6 months. There is no

	mention in Recruitment Rules about how this period is calculated. In this connection, adequate detailed provisions are given in the Office Memorandum No.22011/5/86-Estt (D), issued by DOPT on 10th April, 1989. It was suggested to incorporate suitable provisions in BDL R&P Rules in-line with DoPT guidelines. The suggestion is under management consideration.
6	Systemic Improvement on cutting of sandalwood trees at BDL-KBU by un-identified persons-
	It came to the notice of Vigilance Dept. that around 15 sandal wood trees at various locations in KBU had been cut down during the 3rd week of Jun 2021 and the woods have been stolen by unidentified persons. As this was a major security breach, it was suspected that some internal persons who have knowledge of the area might be involved in this incident. It was suggested to conduct a security audit across units of the company and address the areas of concern effectively. It was also recommended that proper attendance system should be in place to monitor the movement of contract persons/labourers. Further, it was suggested that the incident need to be thoroughly investigated and the persons responsible have to be identified (both internal & external), for which regular follow up with police needs to be done. The suggestions are under management consideration.
7	Inclusion of 'Electronics-Lab' Bhanur Unit under Sensitive Area list & Rotation of Executives working therein-
	A review of systems and procedures relating to rotation of executives working in sensitive areas was undertaken. It was observed that 'Electronics-Lab' department can be included in the Sensitive Area list as the department clears the Goods Receipts (GRs) of Electrical &Electronic components, Electronic sub-assemblies received from vendors and performs similar function to Inward Goods Quality Control (IGQC) deptt. which is a sensitive department. Therefore, it was suggested to include 'Electronics-Lab' in the sensitive department list and accordingly, manpower working in this department will figure in the list for compulsory rotation because of such posting. The suggestion is under management consideration.
8	Medical facilities for Re-employed Ex-Servicemen-
	Provisions relating to medical facilities to employees were studied with a specific focus on provisions regulating facilities for re-employed Ex-servicemen (pensioners) in the Company. Upon reading of Central Organisation, ECHS, Delhi Cantt. letter dated 10.08.2015, it was understood that Ex-Servicemen are required to choose any one Govt. funded scheme on re-employment. Further, it also clarifies that the beneficiary and their dependents have to avail any one type of scheme and not combination. BDL PC No. 13/2001 dated 13.06.2001 on Medical facilities for employees does not have any specific provision regulating the medical benefits for ex-servicemen and their dependents by BDL, if the beneficiary has opted to avail ECHS facility while in service. Therefore, it was suggested that necessary amendments may be made to the BDL Medical Rules keeping in view ECHS guideline which will regulate the ex-servicemen joining the company and already availing medical facility from ECHS. The suggestion is under management consideration.
9	Provision of Deemed Resignation for absence from duty exceeding 5 years in BDL Leave Rules –
	It was observed in one case the executive have been absent from duty for more than 20 years and charge sheet issued against her is pending for long as she is not attending enquiry. It was observed that, Central Services (Leaves) Rules 1972 amendment to Rule-12 dated 29.03.2012 has a provision of 'deemed resignation' for employees absenting from duty for a continuous period exceeding five years. In view of this, it was suggested that necessary provisions could be made in BDL Leave Rules by incorporating a provision 'deemed resignation' in-line with Rule-12 of CCS (Leave Rules) 1972 which will address exceptional case of long absenteeism. The suggestion is under management consideration.
10	Award of Contract without calling tender and Emergency Procurement Procedure-
	Provisions of BDL IMM Manual regulating methods of procurement without tendering such as Petty Purchase, Committee Purchase were studied and a comparison was made with provisions available in other DPSUs. It was observed the financial limit prescribed for such petty purchase is inconsistent with DoP and limit for committee purchase is higher in comparison to other DPSUs. In view of this, it was suggested that conditions for petty purchase and committee purchase need to be clearly defined and lower financial limit should be prescribed as is available in other DPSUs and in Rule-155 of GFR-2017. It was also suggested to incorporate provision relating to 'Emergency/Urgent Procurement' and framing a detailed SoP in this regard. The suggestion is under management consideration.
