Notice is hereby given that the 54th Annual General Meeting ("AGM") of the Bharat Dynamics Limited ("Company") will be held through Video Conference ("VC")/Other Audio-Visual Means ("OAVM") on Monday, 30 September 2024, at 03:00 PM (IST).

The Ministry of Corporate Affairs (MCA) has vide General Circular Nos. 14/2020 dated April 08, 2020, 17/2020 dated April 13, 2020, 20/2020 dated May 5, 2020, 10/2022 dated December 28, 2022 and General Circular No. 09/2023 dated September 25, 2023 and the Securities and Exchange Board of India (SEBI) vide its Circular SEBI/HO/CFD/CFD-PoD-2/P/CIR/2023/167 dated October 07, 2023 has allowed companies to conduct the AGM through Video Conferencing (VC) or Other Audio Visual Means (OAVM) and accordingly the 54th Annual General Meeting ("AGM") of the Company will be held through VC/ OAVM on Monday, 30 September 2024, at 03:00 PM (IST) in compliance with the aforesaid circulars and relevant provisions of the Companies Act 2013 (as amended) (the "Act") and the SEBI (Listing obligations and Disclosure Requirements) Regulations, 2015 (as amended) (the "Listing Regulation")

In this regard, the members are hereby further notified that:

- Members holding shares in physical mode: Register/update the details in the prescribed Form ISR-1 with Alankit assignments Limited, Registrar and Transfer Agent of the Company.
- Members holding shares in physical mode may send their mandates for receiving dividend amount directly into their bank accounts through any RBI approved electronic mode of payments by writing to the RTA at rtat@alankit.com and / or investors@bdl-india.in enclosing the following documents:

- Folio Number and self-attested copy of PAN Card;
- Name of the Bank and Branch where dividend is to be received and type of Account;
- Bank Account No. allotted to you by your bank after implementation of core banking solutions and 11 digits IFSC Code; and
- Self-attested scanned copy of Bank Passbook and Cancelled Cheque leaf bearing the name of the Member or the first holder.

However, in case the company is unable to transfer the dividend entitlements directly through the RBI approved electronic mode(s) the company shall dispatch the Dividend warrant / Banker's cheque / Demand draft to such Members, at the earliest, upon normalization of the postal services.

- Members holding shares in the demat mode should update their e-mail addresses and Bank mandates directly with their respective Depository Participants.
- Pursuant to the changes introduced by the Finance Act, 2020 in the Income- tax Act, 1961 (the "IT Act") w.e.f April 1, 2020 the dividend paid or distributed by a company shall be taxable in the hands of the shareholders. Accordingly, in compliance with the said provisions, the company shall make the payment of dividend after necessary deduction of tax at source (TDS). The withholding tax rates would vary depending on the residential status of every shareholders and the eligible documents submitted by them and accepted by the company. Members are hereby requested to refer to the IT Act and the Notice in this regard. In general, to enable compliance with TDS requirements members are requested to update the details like Residential status, PAN and category as per the IT Act with their Depository Participants or in case shares are held in physical mode, with the company / the RTA.
- The Notice and the Annual Report for the financial year ended March 31, 2024 shall be available on the website of the company i.e. <https://bdl-india.in> and also in the website of the Stock exchanges where Company is listed i.e. www.nseindia.com and www.bseindia.com.
