All of you are aware that COVID-19 positive cases are accelerating in rapid phase in our Organisation despite taking all precautionary measures by all of us.

In this connection as a mark of care and concern for health and well being of all employees and their family members Management is continuously pursuing with hospitals for required medical care for employees and their family members. In this regard, Recognized union and Officers' association are also continuously pursuing with Management to facilitate required support.

Accordingly, in continuation to circular cited in reference, after due endeavor, special tie-up is also made with M/s. Medicover Hospitals, Hitech City and Secretariat for treatment of COVID-19 cases (both inpatient and home treatment).

Further, in addition to the above, M/s. Care Hospitals, M/s. Continental Hospital & M/s. Apollo Hospitals are identified for Home Treatment on payment basis considering the pandemic situation and the reimbursement in such cases shall be restricted to actuals subject to a maximum of Rs. 15,000/- only. This should be based on recommendation of CMO, BDL.

IRC then after detailed deliberations and obtaining clarifications approved the proposal as follows:

- Employees who are tested positive for COVID-19, will have an option of availing Home quarantine treatment plan and kit from M/s Medicover Hospitals or they can avail Home treatment plan/kit of M/s Continental Hospitals, M/s Apollo & M/s CARE Hospitals on cash & carry basis on referral of CMO
- the maximum ceiling for reimbursement of such Home treatment plan and kit will be Rs.15000/-
