I, K Ch Venkat Reddy, Proprietor of C V Reddy K & Associates, Company Secretaries, having office situated at 402, Kamala Towers, Street No. 15, Himayathnagar, Hyderabad - 500029, Telangana, have been appointed as a Scrutinizer for Bharat Dynamics Limited ("the Company") for the purpose of scrutinizing the e-voting & poll process in a fair and transparent manner and ascertaining the requisite majority on e-voting carried out as per the provisions of Section 108 & 109 of the Companies Act, 2013 read with Rule 20 and 21 of the Companies (Management and Administration) Rules, 2014 on the Resolutions contained in the Notice of the 49<sup>th</sup> Annual General Meeting of the members of the company on Friday, the 27<sup>th</sup> day of September, 2019 at 03.30 P.M. at Hotel Sheraton, Nanakramguda, Gachibowli, Hyderabad - 500032, Telangana.

1. The Company has availed e-voting facility from Central Depository Services (India) Limited ("e-voting facilitator") for enabling the shareholders to cast their votes electronically. E-Voting and the poll at the Annual General Meeting venue is conducted under my supervision. At the time of poll, adequate care is taken such that no member who has casted his/her vote



by remote e-voting prior to the meeting is not allowed to cast his/her vote again at the Annual General Meeting venue.

2. The e-voting period remained open from 9.00 A.M. on 23<sup>rd</sup> September, 2019 till 5.00 P.M. on 26<sup>th</sup> September, 2019.
3. The Shareholders holding shares as on the "cut off" date i.e. 20<sup>th</sup> day of September, 2019 were entitled to vote on the proposed resolutions (Item No. 1 to 9) as set out in the Notice of 49<sup>th</sup> Annual General Meeting of the Company.
4. After the time fixed for closing of the poll by the Chairman, one ballot box kept for polling was sealed in my presence with due identification marks placed by me.
5.
